  - Other miscellaneous tasks
- Roger Doran will get the seed money from his personal account and will be reimbursed after the breakfast

The Nominating Committee (TJ Graden, Gerry Hough, and Gary Melvin) – Nothing new.

Gary Melvin reported that the Ogle County Hams (Amateur Radio Operators) appreciated the use of the airport for their Field Day event, at which they heavily promoted the Fly-In Breakfast.

Gary Melvin reported that he has not yet contacted the crop land renter but will do so within the next 2 weeks and will then email the board.

Hangar B4 – Though the owner has been contacted, no payment has been received. The balance currently stands at \$951.09.

The gravel road extension topic was tabled until after the breakfast.

#### New Business:

Raffle Tickets for 2025 was discussed. It was noted that the profit from the 2024 raffle was about \$1,300. Ticket printing costs less than \$40. The topic was tabled until the August meeting.

Gerry Hough mentioned that Dick Schmidt noticed that the water hydrant behind Hangar A5 may have an issue. Gerry will check it and call Martin's if a repair is needed.

A fall pumpkin drop event was discussed. It was suggested that our insurance company be contacted to determine coverage for such an event – Roger Doran will call them.

Steve Friel suggested that the lighting in the "grease shack" be replaced with 4 ft LED units at less than \$10 each. Andrew Mundt made a motion to approve Steve's suggestion. 2<sup>nd</sup> by Roger Doran. Motion passed.

Gary Melvin inquired about where the motor glider could be moved to at the airport so we can begin prepping it for static display. Roger Doran offered his currently unoccupied hangar.
