Call to Order: Meeting called to order at 1801 Hours by Pres. Gerry Hough

**President's Statement:** No statement.

**Hearing of Non-Board Members:** Keith Stranberg make a small Fly-In Breakfast sign for an offsite event. He offered it for use as needed.

# Secretary's Report:

Minutes of the 6 May 2024 Board of Directors meetings were presented. Jon Bargren made a motion to approve the minutes. 2<sup>nd</sup> by Andrew Mundt. Motion passed.

#### **Treasurer's Report:**

Roger Doran presented the Treasurer's Report. Motion to approve made by Gary Melvin. 2<sup>nd</sup> by Jon Bargren. Motion passed.

#### **Old Business:**

T-Shirts – Keith Willing presented a sample shirt. 100 shirts: S - XL = \$12; 2X - 3X = \$13. 150 shirts: S - XL = \$11; 2X - 3X = \$12. Typical selling price is \$20 - \$24. After some discussion, Jon Bargren made a motion to buy 150 Gray shirts in the following size quantities:

S: 10; M: 20; L: 32; XL: 39; 2X: 39; 3X: 10. 2<sup>nd</sup> by Andrew Mundt. Motion passed. Selling price will be set at the 1 July 2024 board meeting.

The Nominating Committee (TJ Graden, Gerry Hough, and Gary Melvin) – Nothing new.

The Ogle County Hams (Amateur Radio Operators) would again like to use the airport for "Field Day", a country-wide event to test emergency readiness. The dates this years are Sat – Sun June 22 - 23. All board members in attendance approved the request.

# New Business:

Crop Land Rental Adjustment – Gerry Hough

Gerry Hough suggested revisiting the rental rate. After some discussion, Gary Melvin said he will discuss a possible rate increase with Josh Nelson, the current renter.

#### Retrieving EAA Chapter 22 chairs – Gerry Hough

It was decided that the several OCPI Board members that are planning to attending tomorrow evening's Chapter 22 meeting will coordinate retrieving the chairs.

#### Thank You Card for Visiting Pilots – Shellie Graden

In Shellie's absence, Gary Melvin noted that Shellie would like to send a Thank You card to all pilots that land at C55 or participate in out events. Each card send out would cost slightly less then \$1.00. Gary Melvin made a motion authorizing Shellie to proceed at her discretion. 2<sup>nd</sup> by Roger Doran. Motion passed.

#### ADS-B Receiver/Reporter – Gerry Hough

Gerry explained that websites like FlightRadar24.com are interested in putting ADS-B receivers at smaller airports to improve coverage and accuracy. The unit reports the data to a server via the internet. The power usage would nearly nothing (a small wall-wart) and the internet bandwidth required would be nearly unmeasurable. Gerry Hough made a motion to apply for a unit. 2<sup>nd</sup> by Jon Bargren. Motion passed.

It was noted that some runway lights need repairing. Jon Bargren and others will work on them as time permits.

It was also suggested that the remnants of the barn quilt on the north end of Hangar A 10 be removed before the breakfast.

#### Liability Insurance Renewal – Roger Doran

Roger reported that our liability insurance expires on 19 June 2024. The renewal cost is \$2,979 for \$1M coverage for all hangars. Roger Doran made a motion to renew the policy. 2<sup>nd</sup> by Gary Melvin. Motion passed.

#### McCarter (Hangar B4) Account Balance

Tim McCarter's balance is \$1,274. All efforts to contact him have failed. Invoices and statements are snail mailed and emailed to him monthly. Gary Melvin reported that his mutual friend knew of no status change with Tim. A certified letter will be the next step if efforts to contact him continue to fail. Gary Melvin will contact Doug Schiller to learn if he knows anything about Tim's status.

#### Real Estate Taxes – Roger Doran

Our real estate is split between Mt. Morris Township and Rock Vale Townships. All the building are in Mt. Morris Township. This year's Mt. Morris Township real estate tax bill increased 18%. The best estimate, based on the details of the tax bill, are that new Hangar C1 accounts for approximately 12% of the increase, which seems excessive. Andrew Mundt, owner of Hangar C1 will contact the Ogle County Assessor's Office to learn more about the evaluaton. It was noted that the first of two real estate billings was included in the most recent monthly invoices. If an adjustment is required, it will show up on the 2<sup>nd</sup> billing. The adjustment, if needed, will be determined at the July Board meeting.

Andrew Mundt asked about edging around his hangar. OCPI has no guidelines.

Andrew Mundt asked about installing a small (250 gallon) sewage holding tank next to his hangar. It was noted that a permit from Ogle County would be required. It would also, most likely, increase his real estate tax. It was suggested that he either install a lift station to pump it into the septic tank. Alternative ideas were discussed.
